

Children and Young People's Clinical Pathway Development Process

The Clinical Pathways Subgroup was tasked by the Chief Medical Officer's Rape and Sexual Assault Taskforce to develop clinical pathways for all people in Scotland who have experienced rape or sexual assault. Consultation for the Adult Pathway and its attendant National Form took place between October 2018 and February 2019.
