Use of Non-lethal Marine Mammal Containment Measures including Acoustic Deterrent Devices (ADDs) at Finfish Farms

Background – Section 3 of the Aquaculture Code of Practice on the containment and prevention of escape of fish on fish farms arising from marine mammal interactions sets out the reporting requirements on the use of non-lethal measures for the purposes of managing interactions with marine mammals, especially seals.

All use of non-lethal measures to deter marine mammals by Aquaculture Production Businesses must be reported to Marine Scotland either on an annual basis. Any use of ADDs requires to be reported every 3 months. This form can be used for the purpose of fulfilling these reporting requirements.

The reporting requirements apply to every finfish farm site located in the marine environment.
