

Consultation on Fisheries Management Measures within Scottish Offshore Marine Protected Areas (MPAs)

Responding to the consultation using the Citizen Space Geospatial tool

August 2024



Introduction

As part of the public consultation on fisheries management measures within Scottish offshore Marine Protected Areas (MPAs), the Scottish Government have included a new geospatial tool into the consultation platform, Citizen Space.

This will allow users to navigate around an interactive map which highlights the location of the MPAs and provides an opportunity to comment at each individual MPA.

This consultation is hosted by Citizen Space and will look familiar and follow the same steps when responding to other consultations. At all stages, the traditional text-based version option is available.

Part 1: Consultation overview - proposed fisheries management measures

When you begin the consultation, the first page you come to asks you four high level questions on the policy approach for fisheries management measures for 20 offshore MPAs. These questions take the form of multi-choice, or open text responses.

At any point in the consultation you can click save and come back later.

Part 1a: Questions on documents

This page consists of open text box responses for the assessments that have been undertaken.

The last question on this page asks if you want to comment on fisheries management measures for specific sites. Selecting 'yes' will take you to a new page with a map for site selection. You can choose to respond in a text-based format from this page as well. Selecting 'no' will take you to Part 2 of the consultation on the amendment of the West of Scotland MPA site boundary.

Selecting yes will direct you to a page showing a map of the MPAs which will allow you to locate and select sites to comment on. You will also be able to select sites from a text list through this page.

Selecting no will direct you to part 2 of the consultation, the amendment of the West of Scotland MPA boundary.

Part 1b: Site specific questions

We have now incorporated an interactive map-based tool to help you when responding.

Whether you use the map, or the text-based site selection list, you will be directed to the same site-specific question page to respond.

Text based site selection response

If you select 'yes' for Question 11 (Do you wish to comment on the measures proposed for any specific sites?), you will be taken through to a page showing a map outlining the Scottish offshore region, and all the MPAs within that area which have measures proposed.

Using this map you can locate and select the site(s) you wish to comment on.

If you do not wish to use the map to choose specific sites, you can click 'Go to the Text Version' available to the top right of the map. Then, clicking continue will take you to a list of sites for you to select which you wish to comment on.

To answer questions on a site, select that site and click 'continue'. You will only be able to select one site at a time. Once you have answered



questions on that site you will have the option to come back to this page to select another site or to continue with the rest of the consultation. You can provide comments on as many sites as you wish.

Multiple choice for site selection

Using this page you can select any sites you wish to comment further on the proposed fisheries management measures.

To answer questions on a site, select that site from the list and click continue. You will only be able to select one site at a time. Once you have answered questions on that site you will have the option to come back to this page to select another site or to continue with the rest of the consultation. You can provide comments on as many sites as you wish.

To select a site to comment on, click the area of interest and the name will appear in a pop up.





By selecting a site and clicking 'continue' you will be taken to the relevant site page. This presents key information on the MPA and outlines the options proposed for fisheries management, including maps to show each option.

A summary and high-level information is provided for each of the sites. We recommend you read the full suite of consultation documents before submitting your response. A link to the relevant document has been provided.

The key assessed impacts for each management option at this site are also shown. These are displayed in drop down menus. The socioeconomic information includes estimated loss in value of landings, job impacts and ecosystem service costs and benefits. The environmental impacts include benefits within the site, spill over benefits and displacement effects. There is also a drop-down menu linking you to the site-specific assessment within each of the relevant impact assessments.

This will provide you with the information to help inform your response to the questions.

You can then choose whether to comment on any further sites.

Part 2: Amendment of the West of Scotland MPA site boundary
