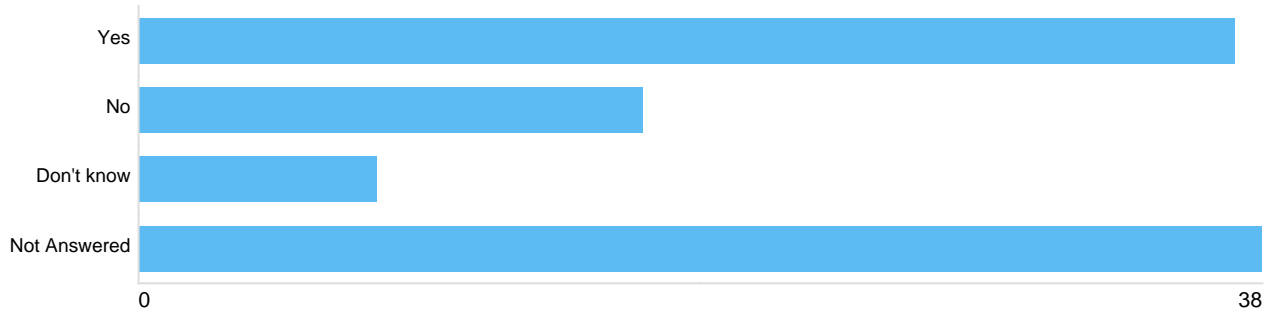

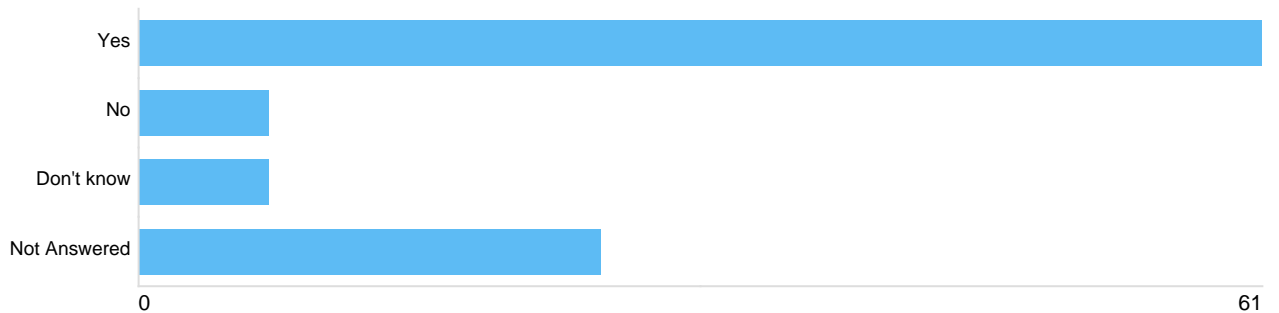

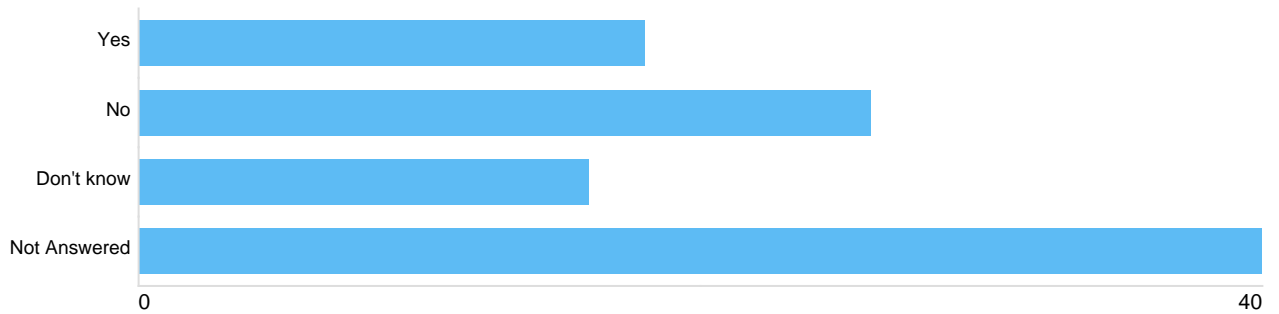

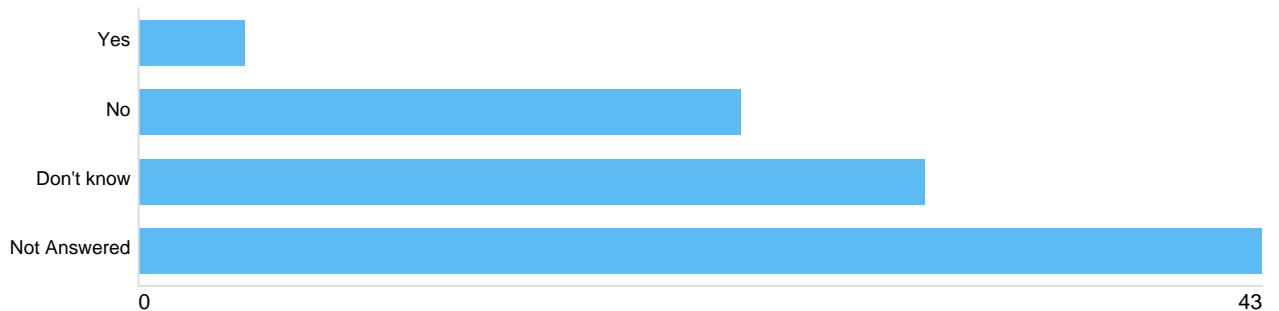

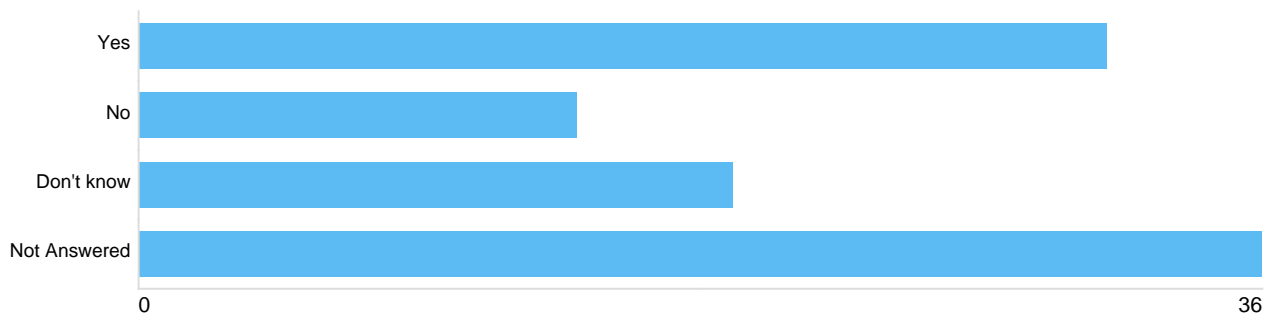

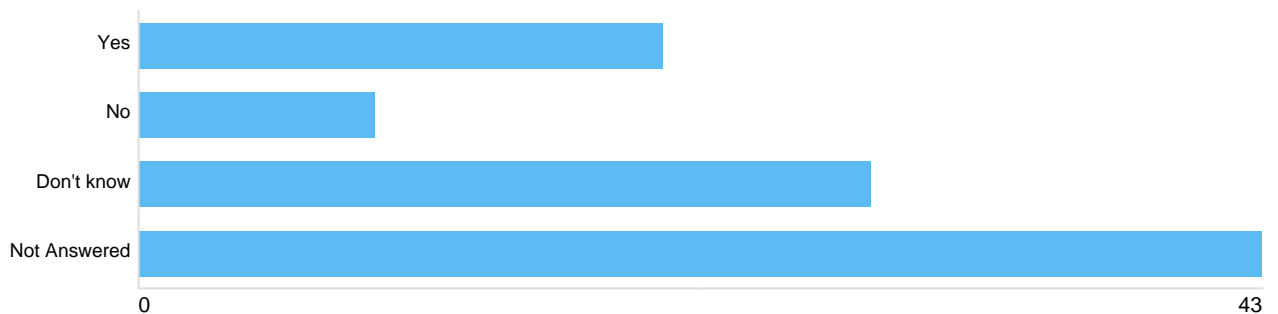

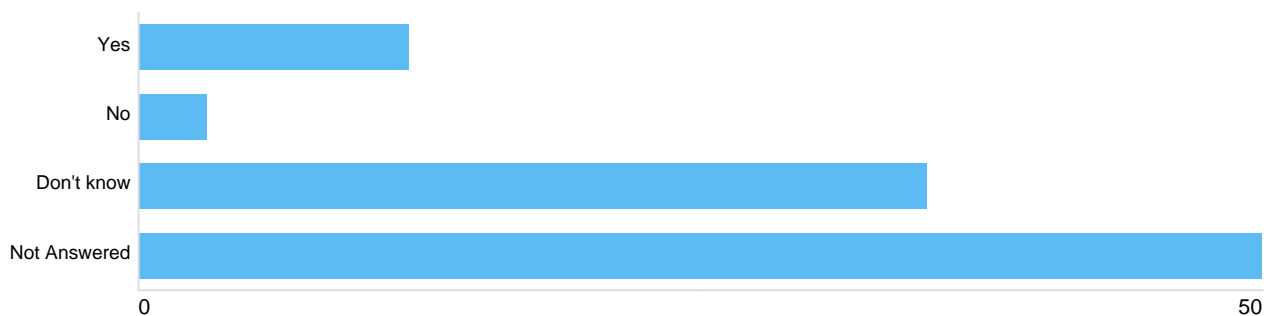

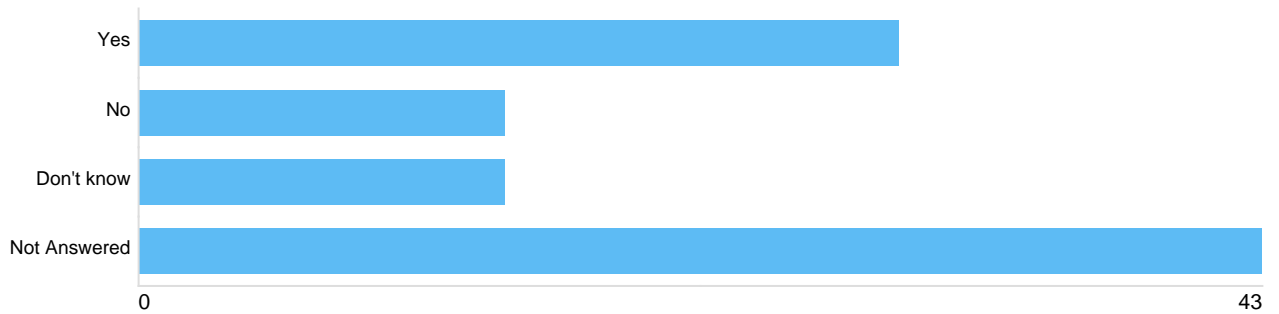

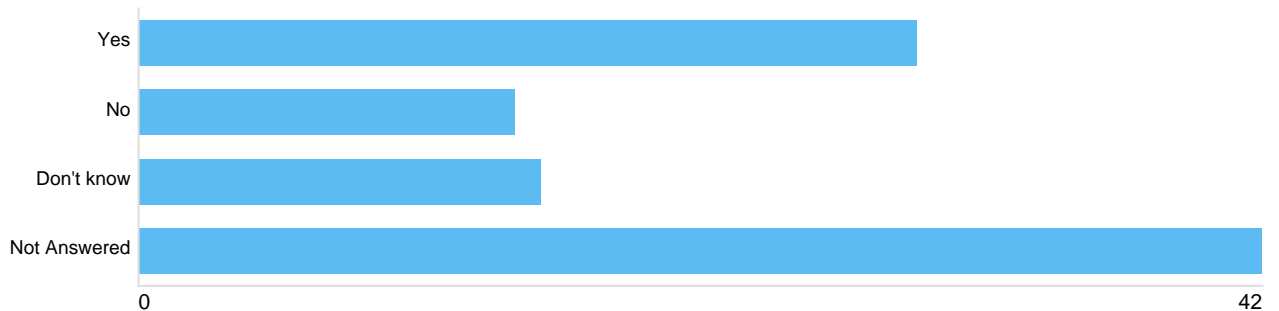

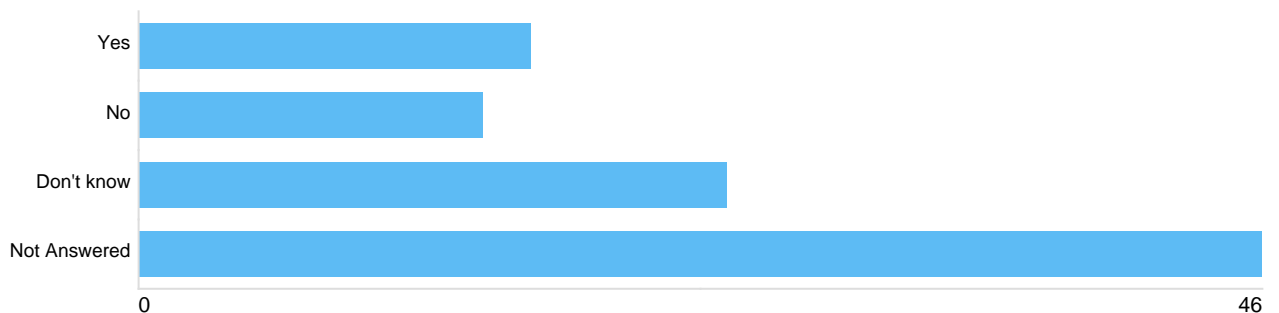

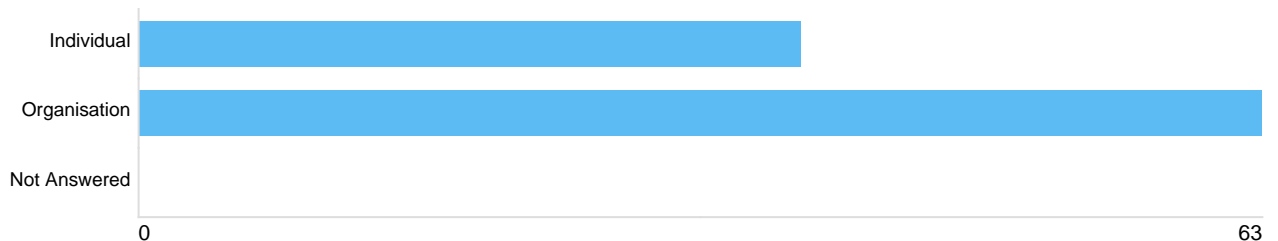

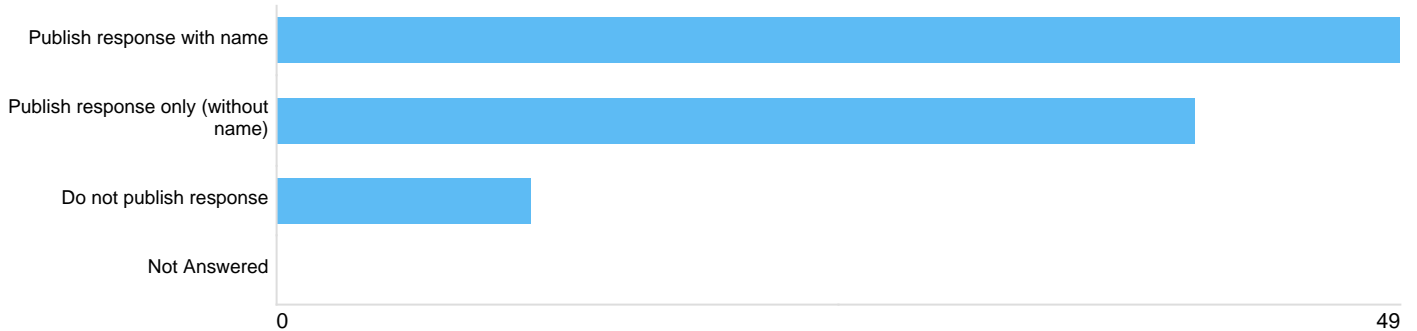

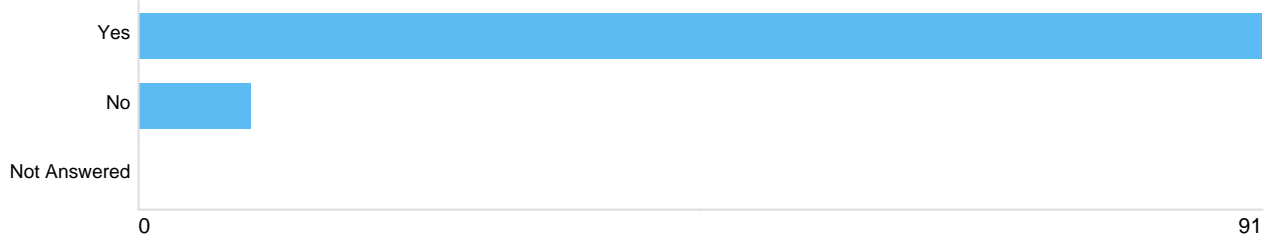

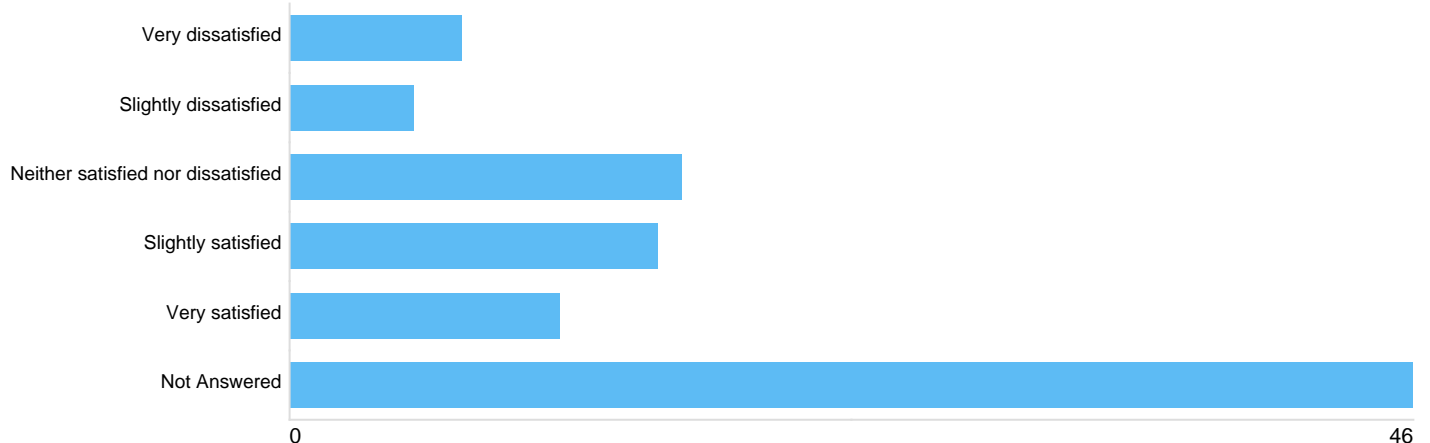

Matrix 1 - How satisfied were you with this consultation?



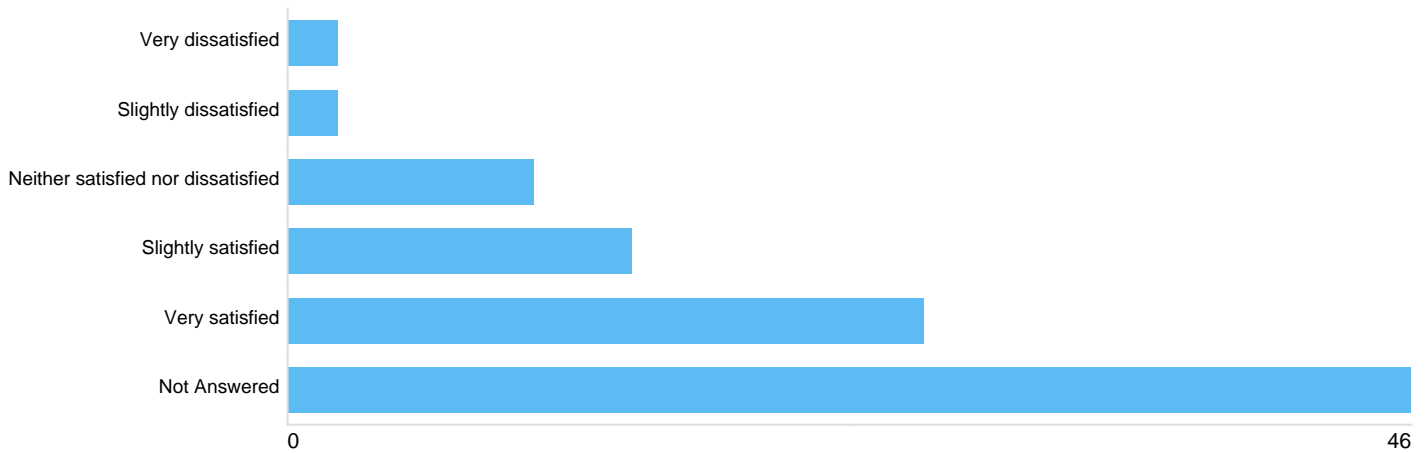
